

## AHN Dance Policy Acknowledgement Form

Dear Parent,

Your daughter will be attending the Academy of the Holy Names school sponsored formal dance. This dance begins at 6:00 p.m. and ends at 11:00 p.m. It is important that you and your daughter are aware of AHN's dance policies. These policies exist to provide a safe and positive experience for the students in attendance on this very special occasion. **Please read the information below with your daughter.** This AHN Policy Acknowledgement Form must be signed and returned to the dance coordinator/faculty moderator, before purchasing a ticket. **Students will not be allowed to purchase a dance ticket unless these forms are completed, signed and returned.**

- **SUBSTANCE ABUSE:** Students at school-sponsored events are not allowed to be either in possession or under the influence of alcohol or any other controlled substance. If there is reasonable suspicion that a student or guest is under the influence of alcohol, he/she will be administered a breathalyzer test. (see AHN HS Handbook, p. 27)
- **BEHAVIOR:** It is the responsibility of the AHN student to ensure that her guest's behavior meets Academy of the Holy Names standards or she will be subject to consequences including the possibility of being sent home from the dance.
- **ATTENDANCE:** All students attending the dance must arrive by 6:30 p.m. and remain at the dance until 10:30 p.m. The parents of students not arriving by 6:30 p.m. will be contacted by an AHN administrator or faculty member to inform them that their daughter has not yet arrived. Students arriving at the dance after 6:30 p.m. will not be permitted to enter the dance, and the parents will be contacted accordingly. **In case of emergency, please call (813) 357-9279.**
- **DRESS CODE:** The dress code is formal attire. Young ladies should not wear any dress that is too low-cut in the front or the back, or that has a bare midriff or cutouts revealing the midriff area. Ladies attire that reveals cleavage or the back below the waistline will not be permitted. For young men, formal attire is a tuxedo or dress suit, tie, dress shirt, dress slacks, dress shoes, and socks.
- **DANCING:** Dance styles that do not reflect the values of AHN and the character and values of the Sisters of the Holy Names will not be permitted. Warnings that remain unheeded may result in the removal of the students involved, parental notification, and, if necessary, disciplinary action.
- **CELL PHONE AND OTHER PERSONAL ITEMS:** In order to prevent the loss of cell phones, cameras, jewelry, etc., while attending the dance, students should keep their personal items with them at all times. AHN is not responsible for the loss of any personal items.

It is our hope that your daughter and her guest have a wonderful time at this dance. We feel by making you aware of these policies, you can feel confident that your daughter will have a safe and enjoyable experience.
